GIFT OPTIONS

Cash. This is the simplest way to give.

Securities. A gift of appreciated or *depreciated* securities can be mutually beneficial!

Charitable IRA Rollover. If you're age 70½ or older, you may make tax-free gifts from your individual retirement account (IRA).

Real Estate. If you own real estate, you may want to consider gifting the property to the Nevada Historical Society.

Bequests in Wills or Living Trusts. Consider including the Nevada Historical Society as a beneficiary of your will or living trust for a specific amount, for a percentage of your estate, or as a contingent beneficiary.

Retirement Plan Assets. Do you have money saved in an employee retirement plan, IRA, or tax-sheltered annuity? You may want to consider giving your loved ones less heavily taxed assets and name the NHS as a beneficiary of these retirement plan assets.

Life Insurance. Your need for life insurance may change as time passes, making way for a new opportunity for its use. You can give a life insurance policy to the Nevada Historical Society or simply name us as the beneficiary.
